

Smitty's Camp Policy

Smitty's is open to receive children from 7:30am until 5:30pm, Monday through Friday. If your child has not been picked up by 5:30pm, a late pick-up fee of \$10.00 per child for the first 5 minutes will be charged to your account. After the first 5 minutes, the charge will be \$1.00 per minute, per child and must be paid at the time you arrive to pick up your child. The registration fee is \$50.00, (unless you attended summer camp and it was already paid). The weekly tuition is \$210.00 per child.. Tuition may be paid with cash, check or money order, is due at registration, and **must be pre-paid at least 2 weeks prior to the break** to allow us enough time to secure the needed counselors. Once your position has been secured and paid for, there will be no refunds or changes allowed.

There is a \$30.00 service charge added to any account that has a returned check, regardless of the reason.

No camper will be allowed to be picked up by anyone who is not listed on your child's enrollment form. Until we are familiar with faces, we will ask for a photo ID from anyone that is picking your child up. We will not accept phone calls or faxes requesting that your child be allowed to leave with someone who is not listed on the enrollment form.

Each camper must bring a lunch, an afternoon snack, and drinks. Please explain to your child that we do not allow campers to share lunch, snacks, or drinks with others due to some of the campers having allergies to certain foods.

Campers are required to bring a backpack each day with a complete change of clothing and extra shoes in case they get wet while fishing or boating. Please be sure that all articles are labeled with your child's name.

No cell phones are allowed at camp. If your child needs to contact you we will allow him or her to call you from the office. If your need to speak to them, please call the office and we will relay a message to them or bring them to the office and have them call you back.

Please understand that if your child brings any electronics or toys to camp, we will not be responsible for loss, theft or damages that may occur.

All wounds must be covered and extra Band-Aids provided for the day. It is the policy of the Duval County Health Department to require campers to be out for 24 hours if they have exhibited any symptoms such as fever, vomiting, diarrhea or rashes. If your child is sick the night before, please do not bring them in for **24 hours after the symptoms cease.** If your child exhibits any of these symptoms while at camp, you will be contacted and expected to pick them up within an hour.

Discipline is the responsibility of the parents, and we will notify you of any problems we encounter. We will speak with the children regarding rules and our expectations of their behavior while they are at camp. If an inappropriate behavior continues they will lose privileges, such as fishing or wagon rides. If their behavior continues to be a problem they will receive a behavior referral or you will be called and asked to come and pick them up. We strongly encourage you to teach your child the importance of respect for authority and respect for the rights and the property of others.
